Steps for Application in brief-

1. Go through admission notification and all other details (including eligibility) mentioned on the college website thoroughly.

The candidates must note the following points while seeking admission at CTM:

- All relevant documents, i.e., mark sheets of qualifying examination, proof of age and documents in support of weightage claimed should be attached by the candidate along with the filled application form. In absence of mark sheets of qualifying examination, the application shall not be considered while preparing the merit list (Such candidates who have appeared in their final semester examination, and are awaiting their results are suggested to enquire about the regulations prior to applying).
- Incomplete/incorrect application form shall be rejected, summarily.
- Provisional admission letter shall be sent to the candidate's email id. (Although the candidates are suggested to check the college website for the merit lists to avoid any inconvenience.)
- The candidates must use the conversion formula for conversion of CGPA to percentage, wherever applicable. The candidates are required to fill up the percentage of marks secured in each examination using the formula wherever applicable.
- The candidate must send scanned copy of each original document (and NOT of their photocopies) along with the filled application form while applying for admission to M.Sc. programs.
- The application will be considered incomplete without the payment of the application fees.
- Selection of candidates shall be based on merit only.
- Applicants need to apply separately with application fees, if they want to apply for both programs in 2022-2023.
- The College withholds the rights to make necessary changes to these regulations and dates (in order to follow latest updates as communicated by Department of Higher Education, Govt. of Haryana and National Forensic Science University). You are therefore advised to regularly check the college website.
